

**BOROUGH OF MT. OLIVER
ORDINANCE NO. 967**

**AN ORDINANCE OF THE BOROUGH OF MT. OLIVER, COUNTY OF ALLEGHENY,
COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 248 (VEHICLES
AND TRAFFIC), SECTION 62 (SCHEDULE X: PARKING PROHIBITED AT ALL
TIMES) OF THE CODE OF MT. OLIVER BOROUGH.**

WHEREAS, Chapter 248, Section 62 of the Code of Mt. Oliver Borough provides a schedule of streets and locations where parking is prohibited at all times; and

WHEREAS, the Council of the Mt. Oliver Borough desires to update and amend Chapter 248, Section 62 to further provide for the safety and well-being of the residents of Mt. Oliver Borough.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Council of Mt. Oliver Borough, and it is hereby ordained and enacted by and with the authority of the same that:

SECTION I: Chapter 248, Section 62 is hereby repealed and the following text inserted herein:

§ 248-62 Schedule X: Parking Prohibited at All Times

In accordance with the provisions of § 248-19, no person shall park a vehicle at any time upon any of the following described streets or parts thereof:

Goldbach Street	Both	From Brownsville Road to Amanda Avenue
Hays Avenue	East	From school building to Ormsby Avenue
Hays Avenue	West	From Brownsville Road to Penn Avenue
John Street	West	From Arlington Avenue to Charles Street

Louisa Way	East	From Margaret Street to Giffin Avenue
