

**TAX LEVY ORDINANCE**

**BOROUGH OF MT. OLIVER  
ORDINANCE 999-23**

**AN ORDINANCE OF THE BOROUGH OF MT. OLIVER,  
COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA,  
FIXING THE TAX RATE FOR THE YEAR 2024 AT 15.5 MILLS**

**WHEREAS**, under the terms and provisions of Act No. 511, "The Local Tax Enabling Act," of the General Assembly of the Commonwealth of Pennsylvania approved December 31, 1965, which Act became effective as of January 1, 1966, as amended, the Borough of Mt. Oliver has the power and authority to provide for the levying and assessment of taxes on persons, transactions, occupations, privileges, and property within the limits of the Borough of Mt. Oliver, and;

**WHEREAS**, pursuant to § 1311 of the Pennsylvania Borough Code, and Council may amend the Budget an the levy and tax rate to conform to its amended Budget; and

**WHEREAS**, the Borough Council of the Borough of Mt. Oliver has determined that it is fiscally responsible and necessary that the tax levied, assessed and collected in said Borough for general revenue purposes to be established at 8.5 mills; and

**NOW THEREFORE, BE IT ORDAINED AND ENACTED** by the Council of the Borough of Mt. Oliver, County of Allegheny and Commonwealth of Pennsylvania, under the authority of the Act No. 511, "The Local Tax Enabling Act," and the Borough Code; and it is hereby ordained and enacted by the authority of the same:

**SECTION 1:** That a tax to be levied on all real property within the said municipality subject to taxation for fiscal year 2024, for general revenue purposes, shall be as follows:

Tax rate for general purposes, the sum of	15.5 mills
on each dollar assessed valuation, or the sum of	115 cents
on each one hundred dollars of assessed valuation.	

**SECTION 2:** All other provisions of Ordinance No. 887 as amended shall remain in full force and effect.


**SECTION 3:** That any ordinance or part of an ordinance conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this ordinance.

**SECTION 4:** Notwithstanding the provisions of Section 1 of this ordinance, the millage rate for general revenue purposes established herein is subject to statutory revision pursuant to the provisions of Act No. 77 of 1994 [Section 3156-B-(a)], and applicable regulations promulgated thereunder.
