

ORDINANCE NO. 1000

**AN ORDINANCE OF THE BOROUGH OF MT. OLIVER, COUNTY OF ALLEGHENY,
COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 248 (VEHICLES
AND TRAFFIC), SECTION 58 (SCHEDULE VI: STOP INTERSECTIONS) OF THE
CODE OF MT. OLIVER BOROUGH.**

WHEREAS, Chapter 248, Section 58 of the Code of Mt. Oliver Borough provides a schedule of stop intersections; and

WHEREAS, the Council of the Mt. Oliver Borough desires to update and amend Chapter 248, Section 58 to further provide for the safety and well-being of the residents of Mt. Oliver Borough.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Council of Mt. Oliver Borough, and it is hereby ordained and enacted by and with the authority of the same that:

SECTION I: Chapter 248, Section 58 is hereby repealed and the following text inserted herein:

§ 248-58 Schedule VI: Stop Intersections

In accordance with the provisions of § 248-13, the following described intersections are hereby established as stop intersections, and stop signs shall be installed as provided therein:


